Member-Guest Registration Deadline Approaching

Room is still available for the upcoming Member-Guest Tournament with the sign-up deadline being July 15th. To obtain a registration form Members may visit the Resort Pro Shop or may download a form through Clubster. To download the registration form from Clubster Members will first need to click on the "Club Links" tab then click "2020 Member-Guest entry form". Tournament Director, Dan Lorig, relays that the September 4th – 6th event will feature two-person teams competing in five nine-hole matches. One match will be played in the morning with another in the afternoon, along with a playoff in the afternoon of the final day. Breakfast and lunch will be provided for each day of the event. There is a cocktail

hour with dinner currently scheduled to accompany an awards ceremony for the final evening but may be altered depending on the COVID-19 pandemic. Cost reductions will be implemented if functions are cancelled and all participants will be notified prior to the event should any changes take place. The overall winning team will have their names etched on the tournament trophy which resides in the Trophy Case in the Resort Clubhouse hallway. Barefoot Club Championship and Member Memorial Tournament Updates



With the ongoing COVID-19 pandemic tournament staff has made a few adjustments to the Barefoot Club Championship and Member Memorial golf tournaments.

For the 2020 Club Championship if participants do not wish to attend the pairing party or awards dinner the cost will be \$100 for golf only. The Club Championship dates will remain the same, August 15th-16th .

Those interested may sign up in the Resort Pro Shop. Sign up deadline for the Barefoot Club Championship is July 15th. When signing up for this tournament please confirm if you will be attending the awards dinner or not. For the 2020 Member Memorial Tournament there has been a change of date and course. The tournament will now take place on September 21st on the Greg Norman course with a 9:00 AM shotgun start. The format will remain the same as flighted captain's choice. If participants do not wish to attend the food banquet following the round the cost will be \$30 for Members and \$50 for guests. If you are attending the food banquet then the cost will be \$45 for Members and \$65 for guests. When signing up for this tournament please confirm if you will be attending the food banquet or not.

Resolving Your Accounting & Billing Questions

Most members are aware that our Accounting Department handles the billing of your monthly dues and charges to your account. Both the dues and account charges charged to the credit card members have on file with the Membership Department. Accounting also sends a statement, usually within the first week

of the month. This lists all the account charges that were incurred for the prior month and dues incurred for the upcoming quarter. For each transaction you make during that month, the statement shows the date the member charged the item to their account, the area or department where the charge was made (golf, restaurant, etc.) and the amount.

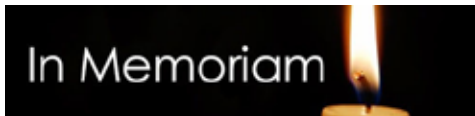
On occasion, members have confused the date of the statement with the date of the individual transactions. The statement date refers to the date when the charges were actually paid by the credit

card and the statement was published, while the individual transaction charges refer to the actual day when the member charged to his/her account at Barefoot. Accounting keeps all individual transaction receipts and therefore can readily do research on a particular item or statement that comes into question. Dues billing occurs at the beginning of each quarter based on the calendar year (currently \$447 for "golf" members and \$189 for "social" members). For those that join in the middle or later part of the month, dues are prorated for that month.

Summer Member Guest and Junior Golf Rates Resort Member guests may now play for \$42 per person after 12:00 Noon or \$61 per person before 12:00 Noon. This discounted rate will run through September 9th. Junior golfers 17 and under may play for \$47 before 12:00 noon or \$36 after 12:00 noon. Junior golfers 17 and under may play for free if accompanied by a paying adult (maximum of one free junior per one paying adult).
